



# WSU Elections Candidate Privacy Notice

When you stand to be an Elections Candidate we will collect and process data that specifically allows you to run in the Election.

## What data do we collect?

Worcester Students' Union hold your personal data including your name, date of birth, university email, gender, course, student number and status (e.g. full/part time) and accommodation type on our membership data base provided to us by the University of Worcester, in line with our data sharing agreement. When you run for election we will ask you to provide your telephone number (this is optional).

Additionally, if you are running for a full-time officer trustee position we will ask you if you are eligible to become a trustee. We will not undertake background checks until you begin employment with the Students' Union if you are successfully elected.

If you wish to claim back elections campaign costs we will collect bank account information in order to process the payment.

## Why do we collect and how do we use your data?

The data we collect enables us to process your candidature and ensure that you are able to run in the election.

Your personal details will be used by our Student Engagement Team in order to perform necessary administrative operations related to your candidacy in the Elections. This includes:

- Checking your eligibility to run in the elections
- Ensuring you are in good academic standing and that running in the election will not hamper your academic progress
- Contacting you regarding your candidacy and during the elections
- If successful to contact you after you have won
- Providing you with an online presence on the website and social media during the elections campaigning period (no personal details other than your name and image will be made available)
- Processing your claim for campaign expenses

We will also use your data to pursue our legitimate interest in monitoring and reporting on participation in elections. All statistical data in these reports is anonymised.





## Will you use my data for any other purposes?

When you sign up as an Elections candidate we will only use the data you provide for that specific purpose to contact you regarding the Elections.

## Who will you share my data with?

When you express your interest, we will share the fact you have put yourself forward with the University as part of our process to ensure that you are eligible to run in the Elections e.g. you are in good academic standing.

We will also share your data with the Director of Access and Inclusion at the University who is the Deputy Returning Officer for our elections and may need to contact you regarding your candidacy.

In extreme cases e.g. an investigation into serious misconduct as part of the elections, we may need to share your details with the National Union of Students who act as our Returning Officer.

Worcester Students' Union Elections are run through a system provided by Membership Solutions Ltd (MSL), who process personal data for and on behalf of the Students' Union, for the purpose of delivering elections. Membership Solutions Ltd (MSL) acts as Data Processor on behalf of Worcester Students' Union.

## How long will we keep your data

We will keep the data specific to your elections candidacy for 3 academic years after the year you stood in the election to enable us to comply with the Education Act 1994, so that we have data should a legal challenge to the election arise and for our legitimate interest to monitor changes in engagement in elections. Analysis of reporting will be maintained for archival value indefinitely.
