8.	Climate Emergency policy motion
	HL noted that CG could not attend this meeting, so as the policy seconder he would be speaking on
	behalf of her.
	HL explained the University has declared a Climate Emergency, and he feels that the Students'
	Union should align with this notion. HL ran through the policy, picking up on key points, such as
	the University being awarded Sustainable Institution of the Year, the SU participating in the
	Responsible Futures accreditation scheme as well as continually achieving Green Impact status.
	HL noted that if this policy were to be approved by Council, due to the financial implications of
	becoming carbon neutral, the policy would be put forwards to the SU Trustee Board for approval before becoming a live policy.
	JG questioned if the policy could set out the SU's aim to become carbon neutral sooner than 2030.
	SW explained that the University set 2030 as a fairly ambitious target, and that to aim for sooner
	than this could be unrealistic. SW also noted that there are only certain elements of working
	towards carbon neutrality that would be within the SU's control. For example, the utilities use of
	the SU building is managed by the University's estates department. Thus, if approved the SU would
	work closely with the University to ensure an action plan was drawn up.
	JG noted that as an Environmental Science and Ecology student, he is supportive of the idea of
	becoming a more sustainable organisation, but that he would hope the policy would be backed by
	a plan of action to work towards.
	THB reassured that if it were to be approved, as a live policy it is the responsibility of the SU to
	work towards the aims of the policy and that it would be periodically reviewed. Student Council
	would be able to hold the SU to account over ensuring this policy is implemented.

9.	Cost for Placement Students to join Clubs policy motion
	MH explained that this policy motion arose from an initial conversation with paramedic students
	who wanted to be part of the SU's Football club, but felt that the cost of joining the club did not
	reflect the value they receive as a placement student, due to being unable to commit to BUCS
	fixtures.
	MH ran through the key points of the policy motion, which proposes to offer a 25% discount for
	placement students and explained the SU has consulted clubs to find their thoughts and University
	staff to find which courses they believe would qualify for having a large placement.
	Consultation revealed the following:
	- Students on placements felt clubs' memberships were not aimed at them
	- Some clubs concerned over having lost of cost.
	- Some clubs were very receptive of the idea, have placement students already and able to
	empathize with those students who were unable to play at BUCS fixtures but paying the

	JG asked if Council approved this would it be applied to all student groups? MH clarified this was

10.	Fit to Study Policy
	MP explained that a 'Fitness to Study' policy focuses on protecting students and their welfare, ensuring students can engage with their studies fully, both academically and outside of this without detriment to their own wellbeing or others in the community. MP noted other Universities have similar 'Fit to Study' policies in place already and this policy would mandate the Union to lobby the University to implement a similar policy at Worcester.
	The University has a 'Fitness to Practice' policy in place already, which ensures students have to uphold a certain standard of behaviour to be on a professional course with placement elements, such as Nursing or Paramedic Science. However, there is currently no policy in place as of yet around the welfare and behaviour of students within the University community.
	This policy proposes the VPE lobbies the University to create a Fit to Study policy in a similar manner to other universities.

	MH noted the following clubs and societies that are due to fold based on their current situation. Clubs: Golf, Cycling. Societies: the Arts Collective, Bhangra Society, Horror Society, Indian Society, Nature Society, Nutrition Society, Lithuanian Society, Polish Society, Sports Coaching Society. MH noted he feels it would be a shame to lose both the Indian Society and Bhangra Society, in the year where there has been an influx of Indian students through UWIC, which could continue to increase next year.
	There was a discussion around Clubs and Societies, highlights include: - SW questioned if this was a normal level of societies to be folding when compared with previous years
	- THB noted that it is often a regular occurrence for cultural societies, i.e. Lithuanian, to come and go every academic year
	 The SU works hard to keep in contact with all societies, noting committees are often enthusiastic but there may be long periods between contact. Societies tend to be more cyclical, and they come and go quite a lot compared to sports
	 clubs as they do not have the same set of goals, and there is a whole host of reasons why they may fold Societies are student led, so up to the students to take the lead on.
	 The Student Engagement Coordinator has been tasked to work on the ongoing sustainability of societies over the summer period.

	HL noted, as Council is aware that the Executive Committee membership will reduce to just the 3 Full Time Officers under the new Constitution, pending the University's Board of Governors approval in June.
	HL updated that no Executive Committee meeting has been held since the last Student Council due to availability of members.
13.	Update from Executive Committee
	Education Council also discussed Harry South who has been elected as Vice President Education for 2020-21, how MP was planning the handover for Education Council.
	Education Council also discussed the last push on National Student Survey and the Course Experience Survey before these surveys close. MP noted that it will be interesting to see how the results of these surveys may be affected and interpreted given the surveys have been conducted throughout the Covid-19 outbreak and a period of intense change. The results will be discussed at Education Council in the 2020-21 academic year.
	MP updated council that the last Education Council was held at the beginning of the changes during Covid-19, when online teaching had just begun. The group discussed students' experiences of transitioning to online learning, which has helped to inform the discussion that MP and HL have had with the University such as shaping online teaching methods and how the university communicates changes with students.

	 MH continues to promote societies who may be struggling for members, but that there could be scope to create a more consistent and concise marketing plan around this. Difficult to promote all societies consistently and fairly, due to the sheer number of societies meaning there would be so many posts. MH explained there are ongoing discussions within the SU beyond just promotion of societies and with students around the purpose and value of societies. For example, could increasing society membership costs to provide more value to the members, as opposed to the model many societies have folded are new societies, changes have been made in the new Bye Laws to support new societies and ensure there is an efficient process to get them off the ground
	 Some general interest societies are quite niche, which may be why they are not getting high levels of memberships, could suggest to them to become more general THB, MH and the Student Engagement Coordinator meet on a monthly basis to go through every society and plan interventions for those struggling SK questioned if there is a possibility for the SU to support these societies by enhancing the promotion of these societies on SU pages and social networks at least every month or so

	the SU's ASM on record, which is particularly positive given the current situation.
