It would be open to students from all backgrounds although with a focus on African and Caribbean culture.

SWig explained that this Society would bring together those with an Autistic Spectrum condition, academics, activists, philanthropists and like-minded individuals to debate on sociological and charitable issues and action solutions. The society would exhibit the abilities of individuals with Autistic Spectrum conditions.

JH asked about the relevance for "Autistic Spectrum" being combined with "Amateur Philosophers". SWig explained that if the Society only concentrated on Autism, it would only attract autistic people. The society's main aim is for like-minded people tackling and solving sociological and charitable issues.

7. Approval of Student Council Motion Proposals

Policy 2017-18_003. Mental Health Service for PGR students

KS explained that the research school have put in a bid for Catalyst funding. The aim of the funding would be to improve support for graduate research students in terms of mental health.

Issues specific to postgraduates include independent lone-working, time-management, high levels of responsibility and managing supervisory teams. Another key issue is working with vulnerable groups. For example, in the Institute of Health and Society, many postgraduates research difficult subject areas such as teen suicide, dementia and mental health. With regards to the 'Student Council Resolves to Take the Following Action' section of the motion, JH made the following comments:

Reporting Items

8. Office for Students Consultation Submission

All Councillors received the Office for Students (OfS) consultation document and the Students' Union's response to this document prior to February's meeting. THB gave an overview of the OfS, explaining that it will change the regulatory framework of the Higher Education sector completely. All University providers will subscribe to the OfS's aims and regulations. JH informed Councillors that the University submitted a separate response to WSU.

EM asked if anyone had any questions about WSU's response or about the OfS in general, but none were received

9. Update from Executive Committee

Executive Committee was held a week before Student Council. JH informed Councillors that the meeting included an update from PTOs about upcoming events and campaigns they are working. An update about WSU's upcoming events was also given at this meeting. WSU's upcoming events include the Leadership Elections and Celebration Week (the Union Awards and the Colours Ball).

Students can currently nominate staff and lecturers via this link for the Union Awards: Students' Choice. JH explained that, because WSU is a charity, it does not aim to make a profit through ticket sales at these awards. However, WSU does need to breakeven with the costs involved in putting on these events. JH went on to explain that students could use the REACH programme as a way of buying tickets for these events. Students' REACH



accounts can be loaded with credit to spend in the online shop (<u>www.worcester-reach.co.uk</u>)

All first year undergraduates, full-time, home and EU students paying full fees at the University of Worcester and joining the University in 2017 are eligible to receive £100 to spend on their REACH account in the 2017/18 academic year. Students in other years (who are full-time EU/home undergraduate students, enrolled in a level 4 or above course, paying full fees to the University of Worcester) are eligible to receive £50 to spend on their REACH account in the 2017/18 academic year.

Action 02: (everyone) to promote the Union Awards: Students' Choice and Celebration Week to students

10. Update from the Board of Trustees

JH explained that this meeting had a particular focus on key performance indicators (KPIs) and long-term goals. WSU submitted its budget proposal for the next academic year and the Board also discussed WSU's affiliation to NUS. JH explained that every Union that is affiliated to NUS pays an affiliation fee (forms a percentage of the block grant). However, because the NUS is no longer being recognised as a charity, the "affiliation" is changing to a grant. WSU are currently waiting for more information about this. THB clarified that the NUS does not qualify for charitable status because of the restrictions on charities political activity and NUS's role as a lobbying organisation, as well as its significant commercial operations.

13. Review of All Student Meeting (ASM)

EM explained that there is a national vocalisation and engagement issue with students. This issue was evidenced at the ASM when quorum was not met. EM asked Councillors if they had any comments and/or feedback about the ASM.

SWig suggested that the ASM should be reframed/rebranded. He explained that most students do not understand the consequences of not coming to the ASM because they do not wholly understand what an ASM is.

EM suggested that the ASM could form a part of next year's Course Rep Conference, as that event saw good student engagement. LP raised the concern that lectures did not know about the Course Rep Conference until after the registration deadline. THB explained that all staff receive internal weekly communications newsletters. Details about the Conference was published on the newsletter well in advance of the event for all staff to see. Therefore, the information is provided but it is just not always accessed.

EM and JH explained that they delivered a presentation on Communications at the Academic Board of Governors. As part of their research for this presentation, they discovered that the best events are when both the University and the Union collaborate and work together. For example, EM is currently involved in delivering presentations on the



NSS in collaboration with Lesley Spiers (from the Institute of Humanities). Due to this collaboration, the NSS completion rate in Humanities is vastly higher than other Institutes. LP informed WSU that she could not access the CES because she is on a joint honours course.

14. Students' Union 'Out and About'

EM updated Councillors that the name "Out and About" is controversial as it causes City Campus students to feel isolated from St John's Campus. The Learning, Teaching and Student Experience Committee (LTSEC) have requested that WSU should change this name due to feedback received from City Campus staff and students. Student Council unanimously agreed to the removal of the Out and About brand from SU promotional events, with immediate effect.

15. PTO Elections Timings

This Agenda item was requested by LP after the issue was raised in the Executive Committee. LP explained that PTO election timings should happen much earlier in the calendar year (e.g. in the month of May) so that PTOs can better prepare themselves for the upcoming academic year. EM explained that PTOs used to be elected alongside FTOs but this overshadowed FTO campaigns, where students are campaigning for a full-time paid job. PTO positions must be available for first year students (who all start in September), and so having an election in May would, most likely, not be feasible. Additionally, the Campus would be very quiet around May due to students heading back home after their end of year exams and assessments. He highlighted that October is the earliest possible time for elections to take place in the first semester due to Welcome Week and the arrival of students. It would be possible to move the elections back to the main elections.

THB clarified that the Governance Review will review the current Officer roles and the current timings of elections. It is hoped that the final proposals for change will go to Student Council early in the first semester of 2018-19. Student Council will be involved in the consultation process.
